Furniture Regulatory Updates for October

Dear Friends,

This is a turbulent time and busy year of changing laws, regulations and compliance dates. Interpretation of these changes and labeling requirements is vital for your security and protection. You must stay informed of this changing landscape and avoid the land mines. The costs and consequences of non-compliance far exceed the costs of being fully legally compliant.

The compliance and regulation laws are complex and depending on the law as many as seven State and Federal agencies can be involved; none of which literally "talk" with each other. In certain situations, if you are not compliant in one State all the remaining States under the law affected are notified immediately. While you might be granted an extension, you might not get this extended time in all cases. The specific State or Federal Agency could pull your non-compliant products from retailers, suppliers, manufacturers, distributors and importers' inventories all through the supply chain.
